International Association of Lions Clubs District 105 SE STANDING ORDERS for use at DISTRICT CONVENTION

- 1. The rules of parliamentary procedure as laid down in Roberts Rules win apply, but the District Governor's decision on any point of order shall be final.
- 2. The conduct of the Convention Proceedings shall be under the Chairmanship of the District Governor, or, in his absence, such officer as shall act in accordance with the International Constitution. In all cases, should the Chairman not be the District Governor, these standing orders shall nonetheless apply as though the District Governor himself was in the Chair.
- 3.
- (a). The District Governor shall have the absolute discretion for the length of time to be allowed for:
 - i) Presentation of reports
 - ii) Comments and questions from the floor
 - iii) Time allotted for the proposing of a Resolution or Amendment
 - iv) Time allotted for the seconding of a Resolution or Amendment
 - v) Discussion on any Resolution or Amendment.
 - vi) The right of reply by the Proposer of a Resolution or Amendment.

The District Governor will give an indication at the commencement of proceedings of the time which he proposes to allow for each. of the above categories, but may, upon informing Convention, at any time alter the period so allotted.

(b). The District Governor shall have absolute discretion in terminating discussion on any subject and all speakers shall yield to the Chair when so directed.

- (a). Written reports presented at Convention will be previously circulated to Club Secretaries and made available to Registered Delegates. District Officers will therefore only speak to their own reports to update information contained therein or to highlight matters as necessary.
- (b). Any Lion wishing to speak on any Resolution or other matter of relevant business must use a microphone and must announce his name and the name of his Club before commencing to address Convention. Only Registered Delegates (or Registered Alternates) shall have the right to vote.
- (c). Any Lion wishing to comment or ask questions on a report. may, with the permission of the District Governor, do so before Delegates vote on the adoption of that report.
- (d). Each speaker must address the Chair only and conform to the time limit laid down by the District Governor at the commencement of proceedings. Other than the Chairman or the Lion moving a Resolution and exercising his right of reply, no Lion shall speak more than once on any one motion or subject, unless it shall be with the consent of the District Governor.
- (e). Each Resolution or Amendment as circulated, must be formally moved by a representative of the Club which submitted that Resolution or Amendment to the Chairman of the Resolutions Committee. All Resolutions and Amendments must be formally seconded. No Resolution or Amendment may be withdrawn without the consent of a majority of the voting Delegates at Convention.

(f). If there is no representative present to move a Resolution or Amendment, then the matter will fail by default.

However, the District Governor may, in his absolute discretion. call for any other Registered Delegate present formally to move and second such Resolution or Amendment so that debate and voting may take place.

- (g). The District Governor shall, in his absolute discretion, be able to accept an Emergency Resolution or Amendment for consideration by Convention if:
- i) that Emergency Resolution or Amendment is submitted to him in writing before the commencement of the Opening Session of the Convention, AND
- ii) in his opinion the Emergency Resolution or Amendment could not reasonably have been submitted to the Resolutions Chairman on or before the closing dates published for the receipt of the same, AND
- iii) a majority of the voting delegates present at Convention consent to the Emergency Resolution or Amendment being so considered.

5

- (a) Save as hereinafter provided, voting shall be by a show of Delegate (or where appropriate, Alternate) Cards, of those present and voting. The District Governor shall declare the result or order a count. If ten or more Delegates challenge the District Governor's declaration, the votes shall be counted.
- (b) Any Resolution or Amendment on a Constitutional matter must have the approval of a majority of at least two thirds of the Registered Delegates present in order that such a Resolution or Amendment shall become effective.
- (c) Any other Resolution or Amendment shall require the approval of a simple majority of registered Delegates present, to become effective.
- (d) In the event of a tied vote, the District Governor shall have a casting vote.
- (e) A minimum of thirty-five (35) Delegates in attendance at Convention shall constitute a quorum.
- (f) i) Voting for the election of District Governor shall be by way of secret written ballot amongst the Registered Delegates attending. Likewise, voting for the election to the office of Vice District Governor shall be by the way of secret written ballot amongst the Registered delegates attending.

ii) All elections shall be conducted by the Single Transferable Vote system as recommended from time to time by the Electoral Reform Society.

DISTRICT CONVENTION REPORTS – FEBRUARY 2025

6. District Governor Team

6.1 District Governor – Steve Carley

It is good to reflect on how we both individually and as a Cabinet team started this Lions year with our aims for the year and also to review what we set out to do in their successes. When looking back at my 1st report to Cabinet as District Governor, I wrote "that my aim is for all Cabinet officers to be more visible, feel empowered and be more proactive with clubs and members across our District in their roles. I continued by stating "I firmly believe we as a District are at a stage where we as a Cabinet team need to be seen more by clubs and leading by example".

I set out the plan that we would have 14 people trained as Guiding Lions, where this group of Lions will be integral to our District Membership Action plan to set up Zone Hubs, where we aim to help support clubs who need help to find new members and to find areas for creating either a branch or a full club. Our Membership team are now actively working on this happening!

At our 2nd Cabinet meeting I asked my Cabinet colleagues for everyone to discuss and write down their responses to 6 questions. This was in response to many clubs saying they are facing challenges in recruiting younger or newer members. Conversely, some clubs were (and some still are) concerned about the increase in membership dues and at the same time are asking us on Cabinet if the increase in subs is worthwhile and if they are getting value for money.

So, 6 questions were asked -

- 1. Why are new clubs valuable? Why do we invite people to join our clubs?
- 2. What type of Speciality Clubs or branch clubs would be most successful?
- 3. Where could a new club (branch or regular) be based (think of locations across our District)
- How can our district team add value to membership in clubs leading to higher retention? Please list what our Lions Club District, MD and International offers us as members. (THE MOST IMPORTANT QUESTION – please be positive)
- 5. How can we help our clubs host Membership Growth Events? How? How Often?
- 6. What training/resources are needed to help us achieve our goals?

All of the table answers have been typed up and were given to our membership team to use in their resources "toolbox" when hosting their meetings and also whenever they are talking to clubs. I now also attach, as a reminder for this Cabinet report as an addendum, the answers provided, so all Cabinet colleagues can use these in their day to day conversations with members.

I have congratulated our Membership team in how they have created stronger and closer relationships with Club Presidents and Club Membership officers through the Membership

Matters monthly Zoom meetings and the newly formed WhattsApp group. I have also sought good news stories from our Cabinet colleagues to reinforce the need to focus on positive activities, rather than negative.

This has been a very enjoyable 6 months of this Lions year – especially when visiting clubs at their club meetings and Charters and I thank all the clubs who have hosted me and the DG team. This is critical in forming relationships with all our clubs where they feel supported with ideas, we gain from all the different meetings and visits we make to share good practice.

So, thank you to everyone I have met so far.

6.2 1st Vice District Governor - Chandra Kumar

The first six months as VDG have been very busy , interesting and informative. Despite struggling to find my feet I have nevertheless found it very enjoyable.

Visiting 14 of the 18 clubs so far allocated to me this year, I enjoyed almost every one of them with the welcome and kind hospitality that was accorded. Visiting clubs and charter events is one of the most fulfilling and enjoyable part of my role, allowing me and the DG team to make new acquaintances connections with club members and share what is going on elsewhere, to ensure we all can benefit from good practices and ideas in fund raising and service. Representing our District is also a great aspect of the role both at club & district events.

These past 20 months (by the time of this Convention) has made me realise how much Lions International invests and promotes the development and training of members across the globe who take on roles from a personal level on the LCI Learn website where there are self- directed modules on skills for everyone, then on a club level, with annual update training for club officers in our Districts to attend Spring Forum; or even at an MD level of individual members being subsidised to attend MD Symposiums which seeks to find future Lions leaders in our MD, or for individuals to attend the MD Regional Lions Leadership Institutes.

In my own development since being on the DG team, it has been an eye opener to see to what extent LCI have invested in online training modules, to in person training both at MD and International sessions. It is no less than perhaps what you would expect for example going in for a CEO interview/Training, very intensive and time consuming, {*Perhaps not a great motivation for new and prospective leaders in my view*}, for a large corporation or multinational company, more especially when you think of it; bearing in mind we are all volunteers, and only contribute a very modest annual membership fee, part of tour dues contributes towards the provision of all these resources to be available for us, should we wish to use.

The second half of the Lionistic year will greatly be influenced by my learning esp at St Charles seminar in Feb 25 just before the District Convention returning back on the convention day of 15th Feb hopefully to make it by late afternoon. It will be a busy time of the year to be getting involved in building my DG team primarily focussed at ensuring that all clubs in the District are included and have a voice and looking for potential leaders.

As part of forward planning we will continue to explore fulfilling the District Goals in relation to membership and new club formations and also the possibility once again the launch of spring forums hopefully in-person as opposed to on line giving us an opportunity of personal interactions. I shall be looking to more fruitful input from the GLT and the GAT teams.

The district 105SE 3 year strategic vision plan for recruitment and retention will continue with more service officers trained and developed via training and support with GMT outlining a plan document. The New Voices team will be encouraged to roll out its specific aims and goals to all clubs. Across all zones membership will be a priority with the ZC's setting up teams helped by Guiding Lions.

It is expected that all Presidents and Secretaries will play a leading role helping the ZC's achieve and formulate a decisive and effective plan.

7. DGLT (Leadership and Training) Team

7.1 District Leadership/Learning Team – Pete Dilloway & Sandra Miles

So far this year we have continued to focus the delivery of training sessions though the use of virtual sessions run on zoom. This has enabled us to provide a variety of sessions, some of which have been run more than once in a cost-effective manner which has provided the opportunity to arrange sessions on various dates to enable more members to attend

Guiding Lions Certification training

The Guiding Lion Program is designed to assist clubs that are newly chartered, established or rebuilding. Certified Guiding Lions provide support to help strengthen clubs and reactivate those that are experiencing difficulties. The Club Rebuilding Program allows more flexibility for District Governors to focus efforts to support weak clubs and those requiring assistance. Club Rebuilding focus on the areas of rebuilding, recruiting new members, training officers and providing meaningful community service

The first guiding Lions Certification training session was run om Sunday 18th August by District Governor Stu Young at which fourteen members of the district successfully passed the Guiding Lions Certification. A further session was held on the afternoon of Sunday 12th January 2025 to enable additional members to become guiding lions within the district. This will also be delivered via zoom. Details of this second session were circulated to all clubs within the district and sent to members that had expressed interest in the first session but were unable to attend on the date. At the time of writing this report 4 members had registered for the session.

Dementia Friends awareness

Arrangements have been made for the provision of dementia friends awareness training, which will also be delivered by Lion Stu Young who is a dementia friends ambassador. This session will be delivered via zoom on the morning of Sunday 2nd February 2025. This workshop which has been successfully delivered to clubs across the Multiple District provides a valuable awareness raising opportunity to understanding the issues surrounding and supporting people with dementia.

MD Newer Members Symposium

This year 2 members of the district attended the newer members symposium which was run by the MD on 29^{th} Nov – 1^{st} Dec.

Continuity planning for potential future leadership roles

We have been developing a list of individuals that may be potential future leaders, whether that be as a zone or region Chairpersons, District Officers, or DG team members. This list is being maintained and updated by the team for use by future DGE's when putting together their cabinet teams. It should also hopefully be of use when looking for potential nominees for 2VDG. If you or a member of your club or zone may be interested in or suited to taking on a potential future leadership role at district level, please contact the leadership development team to provide details. I am also consulting with individuals identified to

establish forward continuity planning of future leadership roles within clubs and the district. This includes identifying and encouraging district candidates for attendance at MD Leadership training events.

Spring Forum

Finally, we are working on the planning and delivery of Spring Forum. which will be held in Spring 2025, including how and when this will be held and what it should cover this year. This includes identifying the most efficient, cost effective and accessible approaches for delivering the spring forum sessions. Delivery via a series of zoom sessions appears to be the most effective, versatile route which provides the opportunity for members across the district to attend sessions on new officers training and other issues during the spring forum from the comfort of their own home rather than having to travel across the district on a specific day to attend an in-person event. This not only avoids the need for members to incur the time and cost of travel to and from the event, and a significant call on the district training budget, but it enables the sessions to be arranged over the course of a week or two so that those members that wish to attend more than one session are able to do so. It also enables specific sessions to be re-run on alternative dates for those that are unable to attend on the initial date. None of which is possible when the spring forum is held in person over the course of one day.

However, there have been calls from some people for the return of the one day, in person spring forum. We are therefore proposing to consult with clubs to identify the extent to which there is demand for and committed attendance by members to sessions delivered at a one day in person event within the district, or a series of zoom sessions over the course of a week/fortnight, as has been the case in recent years. The decision on which option the Spring Forum will be delivered will be based on the outcome of the consultation with clubs, the availability of a suitable venue and its affordability for such an event and the extent to which clubs are prepared to commit to ensuring attendance by sufficient members, as this will entail making a significant cost commitment from the District Leadership and Training budget, which will be ineffective if insufficient members attend.



8.2 New Clubs Coordinator (GET Role) – Simon Edwards

I have been in the role of GET Coordinator for the District since the second cabinet meeting on 29 September. As this is part of the larger membership team I have been working closely with Peter Li and Pam Edwards. It has been an interesting start to my cabinet role. I took part in the certified Guiding lions Course which certainly helps with this role. As part of the Zone Hub scheme myself and Pete Li (GMT) had a worthwhile meeting with the Lion President from NPS Lions Club. Colin reached out to us for ideas for increasing his Clubs membership numbers. A Teams meeting took place after which Colin took many ideas back to his club.

I've taken part in WhatsApp meetings namely 105MD GET/GMT and Membership Matters, this is proving to be a worthwhile and an invaluable resource.

Remotely I was fortunate enough to find a Lions webinar that focussed on using AI, the webinar showed us how to utilise ChatGPT and the Lions specific functions. This has already proved useful.

Work is underway to form a Families Club Branch in Bexhill on Sea. An action plan has been produced, we have a list of interested individuals and a venue booked to promote to initiation of the Branch. We are hoping to sell the idea of families working on events for the local community with the view to eventually forming a Specialty Club if sufficient interest is there.

New Voices

Past 6 months

- 1. Emails were sent to all Club Secretaries for distribution to all their club members explaining what New Voices is.
- 2. Messages have continued to be sent to new members two months after joining and at four months from their joining month with an introduction to the strategy of New Voices.
- 3. We continue to participate with WhatsApp New Voices MD105 and Membership Matters in 105SE where there has been lots of chat and discussions and new things learnt.
- 4. We have had Google teams meetings and a face-to-face meeting with some of the New Voices 105SE team. Lots of discussion and ideas about widening our reach out to new members. We have attended some Cabinet Meetings.
- 5. We have made a plan for involvement of New Voices at District Convention. We hope to be giving out cards of inspiration to our members.

Next 6 months

6. We have had very little or no response to our letters and feel that a more personal face to face approach would encourage more engagement with New Voices and provide that vital link between clubs and the district. We plan to write to all our clubs in the District asking if a member of their club would take up a new position of New Voices Champion, they would

become a link for their club as a 'go between' members and the District New Voices Team. We plan to write a simple 'job description' that would include catching up with all new members, checking if they need any help/support, finding out how they are feeling about being a member and involvement in their club, etc. We think this might increase engagement between club members and the New Voices team and provide that vital link.

7. Our New Voices Team members have been very busy spreading the word about New Voices in their clubs and any other clubs that they have visited.

8.6 Wellbeing & Mental Health for Members – Avtar Sandhu

- 1. About 1 in 4 people in England will experience a mental health problem each year.
- 2. Research shows that adults and young people alike feel their wellbeing is getting worse, with adults also reportedly feeling lonelier. 7.8% of adults in the UK felt lonely 'always or often' in 2024. (Stats from Mind)
- 3. Loneliness is growing at a very rapid pace and the best cure is talking, often to a stranger as they should never judge you for your issues. This helps to break that thought process that may trigger you into that mode of depression.
- 4. I have completed the Mental Health First Aider Course and will be very happy to assist in helping and pointing you or a colleague in the right direction for further support.

I would like to ask a question, real or artificial, tree that is, we all have reasons for which we think is best for ourselves, but did you know you can rent a Christmas tree, and yes, it is only for Christmas. Many companies are now renting out Christmas trees, they will take them back after the festive period, some will be shredded down to be used as mulch, though others are potted and will be cared for until next year. If you do have a real tree just for Christmas, please look for opportunities to benefit from the disposal, there are many useful ways in your area, I am sure. Just a thought on our campaign on waste and lowering CO2.

The UK bee population is still in decline, not helped by open spaces being left to decline or built on. I would urge clubs and members to work within your communities to identify ways to enhance our wildlife habitats. The sewing of sun flowers last year will have helped, and we need to build on this during 2025, sadly we do not have any seeds this year, but why not work with your local suppliers to look at ways of making them available for those with space to grow them, a hands-on approach to promote Lionism in our communities. Working with schools opens so many doors.

The Great British Spring Clean is the nation's biggest mass-action environmental campaign. The Great British Spring Clean and Great Big School Clean 2025 return from 21 March - 6 April 2025. In 2024, the army of amazing #LitterHeroes pledged to pick more than 400,000 bags of litter. Where does all the litter come from? I know many Clubs undertake litter picks, please continue the good work.

9.4 Prostate Cancer Officer – Graham Baldwin

In my first year as District Prostate Cancer Officer, the subject of Prostate Cancer has rarely been out of the news. Clubs within 105SE continue to work with specialist charities that offer help when setting up a Prostate Screening Test PSA event. Primarily, in the SE, this has been arranged via PCaSO, a charity for men diagnosed with prostate cancer run by patients diagnosed with prostate cancer. The charity covers Hampshire, Sussex and Dorset. However, due to unprecedented uptake by members of the public seeking tests, the charity appear to be struggling to accommodate all the requests they receive for PSA testing sessions. I am currently investigating the validity, availability and quality of performance of similar charities, so that I can recommend to clubs an alternative provider, when PCaSO are unable to fulfil the club's requirements. At my own club we have offered free PSA testing for several years and I am happy to guide any clubs through the process, should they want to run a testing session.

The annual report from the MD Prostate Officer (Jon Lines) shows that during 2024 the Lions Clubs have been very busy. UK Lions clubs have tested 11,442 men in the year to 31st December 2024. Details of costs can only be approximated, and it is also estimated that all tests have been provided FOC to the members of the public. The estimated cost of the tests is over £280,000.

There have been several high profile cases that have been in the news, including the frank admission by Sir Chris Hoy that he has stage 4 cancer. This has driven the Minister for Health to announce a formal review of the NHS PSA testing policy. Several senior medical personnel have spoken out against the use of the PSA test, as there can be false negatives and false positives. However, in the absence of a more accurate testing procedure, the PSA test still appears to be one of the best methods of mass screening that is currently available. There are regular news items claiming that new tests, such as a 'saliva test' are proving better than the blood sample required for the PSA test. However, the tests are still in the experimental stage and a lot more data is required before the test can be approved and this could take a number of years. Remember that it can take up to ten years for a new vaccine to be approved for use, so the medical validation process moves slowly, to ensure that the results are correct.

Men who are aged in the high risk group should be reminded that they can request a test from their GP at any time, if they are concerned about their health.

I am aware that there may other clubs that supported directly and it would be great to hear from you. During this year a number of clubs held events to raise funds for Brain Tumour Research.

In May I attended the Bexhill Dog and horse show. The club kindly donated the proceeds from the dog show. In 2025, I would be delighted to support any event which clubs are prepared to host. The next national event is Wear A Hat Day on Friday March 28th. I have hat pins, three of the event hats, which I can pass on to clubs and also a banner. At Adur East we will be hosting the event at the local Artisans market on Saturday 26th April.

The 2025 Brain Tumour Research Golf Day will be held at Hill Barn Golf Club in Worthing on Thursday 17th July. It would too great to have club teams sign up. The flyer was in the last newsletter, but please contact me for further details. Any individuals can be placed in teams.

We also require items for the auction and raffle. Your past generosity has been greatly appreciated.

The cost of research for one day on Brain Tumours is approximately £2740 and clubs which have donated this sum during the last five years, will be acknowledged in one of the research centres. I have more information, should individual clubs wish to contact me. There have been some important breakthroughs in research during the last year, so please continue to support and host events.

9.11 ROAR Officer – David Skinner

The ROAR programme for 2024 has been successfully completed with 17 District SE Lions Clubs supporting 43 schools out of a national total of 146 supported schools. Each school divided into teams of 3-4 pupils and each team developed their innovative idea to improve the world. Each school was supported by its Lions Club which, in most cases, helped with the launch and the judging of the ideas to find each school winners. Three judging teams were appointed to identify the best ideas from the school winners and DG Steve chose our overall winner.

The winning SE school was Westham and Pevensey Primary, entering for the first time, supported by Hailsham Lions. The other selected schools were Woodlands Meed School supported by Burgess Hill Lions and Framfield School supported by Uckfield Lions and Uckfield also ran a 'Mini-ROAR' event for 9 schools.

The ROAR programme engaged over 25,000 children of which over 8000 children were in the South-East. The ROAR Team is helping Clubs to engage more schools in 2024 as ROAR has been clearly shown itself to be a programme which brings big advantages to children, to schools and to Lions. Lions Clubs are clearly appreciating this as, already, we have more registrations than at this stage last year.

9.13 District Leo Officer – Paolo Furlan

Emailed Lions Presidents with the invite to connect, to share their eventual Leo story and to discuss the future of the Leo Club service within their club.

Emailed Adur East to get news about their ongoing attempt to establish a Leo Club within the local school. The club through the candidate Leo Advisor is compliant and periodically contact the School to learn if they decided to take part in the project but there is no advancement. I shared the scanned version of the current youth services brochures to add to the school offer file, so that we can provide a more comprehensive offer.

Future initiative will be:

Contact Zone Chairman to present the project of the Leo Club to Zone clubs. Launch a Zoom meeting with club presidents or their representative to explain once again the program.

9.14 Youth Exchange Officer – Paolo Furlan

Emailed Lions Clubs Presidents with brief presentation, launched 2 appeals one for hosting families and one for club sponsors. Shared the Program official Handbooks for Hosting families and Clubs Sponsors.

Discussed the Youth Camps and Exchanges with Bromley Club, no decision has been taken as time is needed to consider the two appeals. However detailed description of the camp program and sponsoring condition has been requested as well as more information on how to become hosting families. I shared the Handbooks provided by the Program and might discuss again the details in the next Club cabinet which will take place in February.

Attended a MD of the YECs end of November in Birmingham to discuss current needs.

Future initiatives will be:

a zoom call will be organised with Club Presidents to introduce better the Program and its needs for summer 2025. We basically still need hosting families that can host foreign students for 10 days from 1 to 11 August 2025. The applications should arrive before the end of March.

A second request is to sponsor one or two students going abroad.

Ideal is the collaboration at zone level to share the relative burden of hospitality and activities to organise and for this reason I will attend the closest zone meetings or those of the most interested zone to promote collaboration.

9.15 Lions International Blood Research Appeal (LIBRA) – Andrew Lodge

Going for Gold Campaign - we are over 2/3 of the way through meeting our target of £300,000 so we hope the final push this year will help us reach our target.

Dame Kelly Holmes continues to support LIBRA as our Ambassador.

The new Derek Mitchell ward, which was refurbished and opened by Dame Kelly Holmes on 3rd May 2023, has been a great success for patient care, and the new environment for patients enhances their recovery through the treatments they undertake.

Dr Stephan Menzel joined us at a recent Trustees meeting to outline to us the recent Sickle Cell research updates. There have been superb advances in genetics of foetal haemoglobin linked with his joint research with Professor Thein, now in the USA. This exciting research has now led to enhanced treatments which greatly assist patients in their recovery.

We saw in 2024 our first Clubs visit to Kings since covid and we have another Club visit to Kings planned for Wednesday 30th April 2025 at 2.30pm. PDG Eddy Warn will be pleased to hear from Clubs wishing to visit the haematology department.

Chairman attended an excellent nursing conference at Kings and a further celebration of the previous Head of Haematology, Professor Ghulam Mufti, of his career.

We are pleased to welcome Head of Nursing for the Haematology department, Carole Cobain Patel, to our Convention along with some of her colleagues to present an update on patient care and nursing within the department.

My thanks for all the Trustees' support this year and for our Lions Clubs in SE for their generous donations to help us support this amazing haematology department with their equipment needs, ward refurbishments, research and patient care.

Andrew Lodge - Chairman of LIBRA

Research at King's leads to a new treatment for sickle cell disease

As recently reported by the <u>BBC</u>, a new form of therapy for beta haemoglobinopathies has recently been made available through the NHS. Patients' own bone marrow is stimulated by gene editing (CRISPR/Cas9 technology) to activate a form of haemoglobin ('foetal haemoglobin') that is unaffected by the sickle mutation, thus protecting patient's red blood cells and preventing or reducing painful episodes for those treated.

This new therapy is based on the discovery of a molecular 'off switch' for foetal haemoglobin, a transcription factor called BCL11, by international researchers, with the team from King's being the first to publish this in 2007. The work was led by Swee Lay Thein, Professor of Molecular Haematology at King's at the time, and is presently continued here by Stephan Menzel, working closely with an informal grouping of KCL and KHP academics, John Strouboulis, David Rees, Ghulam Mufti, John Brewin, Kate Gardner and others.

Cost to the NHS currently exceeds £ 1.6 million per treatment and will therefore be available to a small group of carefully selected patients only. Thus, the search for additional therapeutic strategies continues, here at King's and internationally. KCL researchers are working together with colleagues in Nigeria, Tanzania, Brazil and the US.

Stephan Menzel's research is presently funded by the Medical Research Council (-> link to new KHP pages) and he and John Strouboulis have recently been awarded a grant by the Foetal Medicine Foundation (-> link) to work with a London Biotech start-up, MiNA Therapeutics, to investigate new ways of activating foetal haemoglobin. Other support is being received from King's College Hospital Charity (-> link) and from LIBRA (Lions International Blood Research Appeal -> link).

Helen Rooks was part of the original team that discovered the role of BCL11A. She is presently employing cutting edge genomic technology (single-cell transcriptomics) to understand how foetal haemoglobin is produced.

9.16 Air Ambulance – Howard Lee

Milestones for KSS and for Lions Air Ambulance Appeal

2024 was another busy year for Kent Surrey and Sussex Air Ambulance (KSS) as they celebrated 35 years of service to our community. During 2024, they undertook over 3,000 missions and attended around 1,700 of the most seriously injured people in the Southeast. This equates to nine missions each day across the region. We Lions can be justly proud of the part we are playing in helping KSS to save lives, and an update from KSS is given below

And 2024 was also a milestone for the Lions Air Ambulance Appeal, as we reached a massive £500,000 raised for join projects with KSS since the appeal started in 2012.

Since our last Convention, we have provided seven new video laryngoscopes and eleven sets of newly designed medical kit bags. We are also well in the way to providing another rapid response vehicle due for purchase during 2025. All these projects have been described in detail in previous reports and newsletters.

Since 2012, our wonderful partnership with KSS has achieved the following:

I cannot give enough thanks to all those Lions and Clubs across the District who have provided such great support to bring about these achievements. In particular at this time, I would thank all those involved in the Bluebell Walk that has raised over £32,000 in the last 10 years. I would also thank the Hastings Lions Club for its recent very generous pledge of £25,000 towards the rapid response vehicle for 2025.

Our Work with the Air Ambulance Continues to Grow

As referred to above, we are now working to provide KSS with a new much-needed rapid response vehicle. This will cost around £52,000, and we have around £35,000 so far. So please keep those donations coming in.

I make no apology for repeating the reasons for our support for KSS. The life-saving service they provide is vital to the well-being of all people in our area, and its objectives are in total alignment with our own. Through our partnership with KSS, we can identify exactly what wonderful results our support produces, and how many lives it saves. We can truly say:

Lions helping in the fight to save lives

I thank all the Steering Group members (see list below) for their dedication and hard work, and I would entreat all Lions Clubs in SE to continue to support this life-saving initiative by sending donations to the District Charities Treasurer through the normal channels.

Kent Surrey and Sussex Air Ambulance (KSS)

Going from Strength to Strength

KSS medical emergencies have continued to grow and are now the largest mission type at 29%, in comparison with road traffic collisions (RTCs) that have fallen to 26%. This can be attributed to a number of reasons, one being an aging population, but also there are now more people within the community with more complex medical needs owing to either the effects of Covid or through missed medical appointments to maintain necessary treatment.

In its quest to provide the best service possible, last year KSS live-streamed CPR awareness training to 17,000 people, including 8,000 school children in 60 schools. South East Coast Ambulance Service receives approximately 3,800 calls for out of hospital cardiac arrest every year. For such incidents, survival rates nationally is just 11% with chances of survival decreasing by 10% with every minute without defibrillation, from 90% after one minute to just 10% after 10 minutes. Bystander CPR and defibrillation can make a huge difference, doubling chances of survival.

Restart a Heart Day 2024 took place in October, and KSS reached over 80,000 people through a week of activities both online and face to face in multiple shopping centres, Gatwick Airport and other public places. We Lions were also given our own chance of learning this lifesaving skill at Lions Day with KSS in September.

Using technology to save lives, and KSS is now testing if drones can deliver defibrillators to people in cardiac arrest. KSS was recently approved to join the Civil Aviation Authority's "Beyond Visual Line of Sight (BVLOS) Sandbox", one of just six providers from across the charity and commercial world approved to test drones use in UK airspace. They will begin testing south of Gatwick in 2025.

KSS is also taking steps towards flight in lower visibility. Currently, visual flight rules mean that pilots must be able to see 3,000m and clouds must be above 500ft for them to fly. At night these criteria increase. KSS helicopters have the technology to fly when these criteria are not met and we are working to do so safely, which could reach 150 more patients a year by air.

KSS Patient and Family Aftercare Service (PFAS) provides continuation of care. As well as providing a vital element of their care giving to former patients and bereaved families, the KSS team recently completed some cutting-edge research measuring their impact which will be used to guide their future work. One paper focused on anxiety levels experienced by the crew before a patient meeting and how this reduced after the experience, highlighting the importance of the protection measures put in place by the team. Other research focused on a patient's perspective of their rehabilitation experience and how the ongoing engagement from PFAS is vital to their journey and enhanced quality of life.

10.3 District Treasurer – David Butler

My fellow Lions, once again, I have been happy to serve as your District Treasurer and hope that the following summarises what has happened during the year together with what is planned for the Lions year 2025-26.

2023-2024 District Administration Accounts

As District Treasurer, I have prepared the accounts for the administration funds held by the District for the year ended 30 June 2024. These accounts have been independently examined and were approved by our District Cabinet on 1st December 2024.

I am, again, indebted to our Independent Examiner Lion Roger Hope from Sevenoaks, who has signed the accounts as being satisfactory.

The Administration Accounts are attached as Appendix 1.

Accounts for the District's Charity Foundation and the Convention Fund are reported on by District Charity Treasurer PID Howard Lee and District Convention Chairman David Burstow respectively. These accounts are presented separately.

2024-25 International, MD and District Dues

Members' dues payments for the first half of this Lions' year have been received from all Clubs and the appropriate amounts forwarded on to LCI and MD.

Requests for payments for District and MD dues together with details of the amounts requested by LCI for the second half of the Lions' year were sent to all clubs during week commencing 6th January. I am pleased to report that, as I write, a number of Clubs have already paid their dues and I expect that by the time Convention starts all Clubs will have paid their dues and therefore be in Good Standing.

Proposed Budget for 2025-26

I have prepared a budget which reflects the District's current membership position and the potential for a further small decline by the end of the year. The budget also includes a reduction in DG and admin team allowances which should follow a planned reorganisation of financial administration. The resultant budget, although it includes a small reduction in overall expenditure, still forecasts a deficit for the year. As a result, the current dependency on a draw down from reserves will need to continue.

The budget is set out in Appendix 2 and was reviewed and approved by Cabinet at its meeting on 1st December 2024, ready for adoption at Convention.

Proposed Dues Resolution for Convention 2025

Despite the dependency on reserves to create a balanced budget, I have recommended that the current level of District dues continues in 2025-26. Members have faced increases in District, Multiple District and International dues in the current year so are unlikely to welcome yet more increases in the level of District dues when we still hold significant reserves.

On 1st December 2024, Cabinet gave their agreement to the following resolution to be proposed and seconded by the District Cabinet:

This Convention resolves that the District per capita dues for the Lions fiscal year 2025-26 shall be £12.50 per member per annum and that the dues shall be invoiced in two equal instalments being 1st July 2025 (based on the membership numbers recorded on the International website as of 1st July 2025) and 1st January 2026 (based on the membership numbers recorded on the International website as of 1st July 2025).

Club Accounts for the Lions year 2023-24

Lions Clubs' accounts for 2023-24 can be submitted in hard copy or electronically to <u>treasurer@105se.org</u> I am duty bound to remind Clubs that, if registered with the Charity Commission, their Annual Return should be submitted in a timely fashion (normally by the end of April) to the Charity Commission.

The reason for me wishing to see club accounts and TARs is not to check a Club's viability or financial status but rather for the District to have the comfort that all Clubs are complying with their obligations under the Charities Acts and in so doing maintaining the good name of Lions Clubs International. The requirement for all Lions Clubs to submit copies of their independently examined accounts to their District Treasurer was carried by resolution at MD Convention.

Forthcoming Changes to District Financial Administration

For many years, District 105SE has operated with both a District Treasurer and a District Charities Treasurer. We are the only District within our Multiple District to favour such a structure – the others have a District Treasurer who looks after both the District's administration finances as well as those relating to the District's charitable activities.

Having advised the DG and our District Charities Treasurer at the beginning of this Lions year that it would be my last as District Treasurer, we are taking the opportunity to reorganise the administration of the District's finances. Work has already begun and following the approval given by the DG we will, by the end of the current year, have combined the activities of the two current finance roles into a new single role of District Treasurer which will be taken on by PID Howard Lee. Howard and I will continue to liaise in the coming months to ensure a smooth transition, any additional adjustments to bank mandates which may be needed, a handover of files and the construction of new District Financial Procedures.

District Treasurer's notes to the accounts:

- 1. The level of the annual District per capita membership dues was maintained at £10 in 2023-24. Dues income received was as follows:
 - District Dues £11,155
 - Multiple District Dues and Insurance Payments £41,246.75
 - International Dues £41,624.06

Multiple District dues and insurance payments together with International dues were forwarded, in full, to MD105 and LCI respectively.

- 2. The District maintains two accounts (Cabinet Members and Event Payment) for Cabinet events such as lunches following Cabinet meetings. The accounts are funded entirely by payments from Cabinet members. Any surplus generated if venue invoices are slightly lower than members' payments are credited to the Cabinet Members Account and has been added to interest earned.
- 3. The amount shown was transferred to the Convention Account during the year. The Accounts for the Convention are presented separately.
- 4. Once again, greater investment was dedicated to leadership training via courses organised by Multiple District.
- 5. There was no International Draw Competition during the year.
- 6. The balances of the District's Administration Reserves accounts can be seen on page 2. The total of the Reserve Fund balances stood at $\pm 32,259$ at the year-end.
- 7. The NatWest collections account is used to receive deposits from Clubs both for dues and payments to settle LCI invoices, for example for new members. Once payments are identified they are transferred to the relevant Barclays account or paid to MD105 or LCI.

The District has several items of Fixed Assets. These are either Lions specific items which are relevant only to Lions International and District 1055E which have no resale or intrinsic value. Other IT items, because of their relatively low initial cost and current age are similarly of no resaleable worth or asset value.

DISTRICT FINANCIAL REGULATIONS

The District's Financial Regulations, the "Procedures for Financial Governance" are reviewed each year by the District Finance Committee. A copy of the current version is available and can be provided upon request to the District Treasurer.

DISTRICT CONVENTION ACCOUNT

The District maintains a separate Convention Account which is reported on and accounted for separately. The Administration accounts above record only the total funds transferred to the Convention Account.

Notes

Income

- 1. At the time of preparing the budget, membership in the District was 1,077. It is likely we may lose members during the year, but as we are still aiming to recruit new members a membership base of 1,050 has been suggested for 2025-26.
- 2. Income from dues has been calculated at £12.50 per member in anticipation that Cabinet's proposed resolution for Dues in 2025-26 is adopted by Convention.
- 3. The level of District Dues will continue to be reviewed annually.

Notes on Expenditure Proposals

- 4. The Forum/Training budget has been set at £1,000, which is higher than expenditure in 2023-4 in anticipation of greater forum costs in the future.
- 5. The overall Membership Development budget has been retained at £1,500, despite low levels of historic spending, in view of the desire to increase membership.
- 6. The District Service budget line has been retained at £500.
- 7. The communications budget has been maintained at £1,000 reflecting the higher levels of District web expenditure.
- 8. The budget line "DG Project Budget" added for the current year has been maintained to facilitate action on projects which may arise during the year.
- 9. The DG and admin allowances budget has been reduced in anticipation of lower costs resulting from some admin reorganisation.
- 10. The budget for Convention has been maintained at the current year's budget figure.

Dependency on Reserves

Dues income is again reducing following the trend in membership. Although budgeted expenditure is slightly lower than the current year it is still significantly higher than projected income. Consequently, there will still be a need to draw down from reserves to balance the budget.

10.4 District Charities Treasurer – Howard Lee

At the time of writing this report, the Financial Statements of the Lions Clubs International District 105SE Foundation ("the Foundation") for the year to 30 June 2024 are undergoing independent examination by a professional firm of chartered accountants. I will let Club Treasurers know when they are available.

Thank you for all your support for our Lions projects in the District and Multiple District, and Internationally through LCIF. The movements of funds through the Foundation bank accounts for the six months to 31 December 2024 are set out in the attached schedule.

Since the last Convention, the Trustees of the Foundation have made two grants of £3,000 each for projects of the Dartford Lions Club and the Cranleigh Lions Clubs for the support of Ukrainian refugees and displaced persons.

They have further pledged £300 each to diabetes screening programmes to be held during 2025 by Uckfield Lions Club and Tonbridge Lions Club.

The Foundation has funds available for grant applications from Clubs in the district:

- to provide aid to those in need in or from the countries around Belarus,
- for diabetes screening and awareness in the community, and
- for the relief of distress within the District caused by natural disasters.

If your Club has need of assistance from these funds, please contact me for details.

During the last year, the Trustees also pledged to support up to six schools wishing to enter the ROAR 2024 competition, but without individual Club sponsorship. This pledge was not called upon.

PDG Lion Tom Berry and his team continue to do great work developing the facilities and use of the Lions Giving website. No doubt Tom will report in more detail elsewhere. However, there are costs involved, and the Trustees of the Foundation are now exercised in the consideration of how best to meet the costs concerned. The best way for Clubs in the District to support this excellent work is to make full use of the facilities offered by Lions Giving, so please contact Tom for full details.

WORK UNDERTAKEN: I continue to provide assistance to Clubs and the District as required. This has been with the ICO fee process and the reasoning behind my advice, but this year has mainly revolved around other aspects of compliance such as Privacy Notices. I am happy to assist all clubs in the District with this matter.

With regard to Privacy Notices and the other required documentation, Convention should note that I provide these services through my business free of charge to Lions – this means that I have effectively donated my fees to the District. I would normally charge a discounted fee of £150 to charitable organisations such as Lions.

I am happy to continue with this as I am approached by Clubs.

I must stress that my recommendations are only ADVICE based upon 25 years of experience professionally in this field – a Club gains nothing by trying to argue the points of compliance with me.

TRAINING:

I am still happy to provide training sessions for the District if the interest is there. A training workshop has been provided in the past and I am happy to do so again in conjunction with the GLT lead. I am attending the Faculty Development Institute at the end of January to ensure my skills in this area are accurate and up to date.

PORTAL:

I have provided, through the DG team, an article about the Portal and access restrictions to personal information. I am happy to answer any resultant queries, especially if any Lion is concerned about the privacy of their information.

LEGAL ACCESS: The International Data Transfer Agreement (IDTA) with LCI Oak Brook is in final stages of draft. This will allow each Lion to access the Portal in line with UK law. The previous Agreement required a re-draft after the law changes in 2018, but it took a long while to get finalised guidance from the UK Supervisory Authority on data protection/UK GDPR, the Information Commissioner's Office (ICO) to ensure the finalised document will be appropriate. At the time of drafting, the final text is with Oak Brook for approval, which I am hoping will be before Convention itself.

Unfortunately, a Zone Chairman couldn't be found for this new Lions year even though clubs were asked for any volunteers. It is hoped that there may be a President or Past President who may be willing to take on the role 2025-26. Please let DG Steve or Vice DG Chandra if you can take up the role.

Bognor – The Club albeit small in number have provided marshalling for a 3 day music festival which went well and a static 3 day Christmas collection. They have run many tombola stalls at local events and a book case. They have asked the District for help and the GMT Chair has created a membership plan that has been sent to local Guiding Lions to support Bognor.

Chichester – The club are still sorting specs and launched their Carol float throughout the city. They had a successful Swim Marathon and It's a Knockout community service event. They attend regular fetes for fundraising.

Lancing & Sompting – The club have continued to support LCIF & responded to disaster appeals. They have attended local events fundraising and did a Santa tour throughout December. Worthing – They have had successful fundraising events such as their Summer Festival, Party in the Park and they had a successful PSA Prostate testing event. Their charity shop and selling of mobility scooters is going well.

Midhurst - : They are delighted to say we have 5 volunteers helping us at events who are all very keen to volunteer and help us in any way they can,

Bognor 8th March at Bognor Golf Club Littlehampton – proposed only date 25th April 2025 Southbourne – June 2025 Midhurst - Perhaps we will be able to join forces with another club in our Zone to hold a joint event.

13.2 Zone Chairman 1B - Claudine Rogers

Clubs in Zone 1B include Adur East, Billingshurst, Brighton, Burgess Hill, Haywards Heath, Horsham and Rottingdean & Saltdean. Club visits are continuing into 2025, and a Zone Social is currently being organised for 2025 which will encompass Members attending a Quiz in Haywards Heath (with the added benefit of it being used as a potential membership event). It is anticipated that Members from each Club will attend, strengthening Zone relationships. The total number of Members across all Clubs is 159.

Adur East continues to be a very active Club. With an extensive array of social activities, Members continue to run annual events such as Senior's Tea Socials, Car Boot, a monthly Market Stall and their hugely popular Family Fun Day. Monthly donations are made to two local Foodbanks, who also benefit from Wencelas payments (the latter most notably are able to continue, thanks to a £5,000 grant obtained by their Treasurer, Richard Behling). In most recent weeks they have run numerous festive community activities, such as a static street collection (with Santa giving out free toys), a week of Sleigh street collecting (with Santa giving out free sweets), and also a Santa's Grotto over 5 days. Their largest event for 2025 will once again be their annual Family Fun Day, to be held on 8th June (31 Members).

R&S continue to run, and be involved in large annual events, such as the Rottingdean Fayre (on 14th June), & the Saltdean Gala (on 19th July). Christmas activities included their famous Highway Robbery on 14th & 21st December, Senior's Christmas Lunches on 2nd & 10th December and also a Christmas Fair on 7th December (which luckily was held indoors during storm Darragh). Despite having to manage with reduced funds (as a result of losing two key fundraising events last year), they continue to provide extensive support to their local community. Their Christmas parcels, for example, (made up of food and gifts) helped support 154 children & 132 adults. R&S Lions will also be supporting the Zone by running their fabulous Bar at Adur East's Family Fun Day (17 Members).

Brighton Lions continue to run a whole host of regular activities, covering events such as bingo, book fairs, crafting sessions and donations/deliveries to local foodbanks. December also saw their annual Christmas toy delivery to the Royal Alexandra Children's Hospital, and food delivery to a new Food bank based at a local primary school. Brighton also donated 50 boxes of biscuits to the area's MS Society for their Christmas party. (15 Members)

Sadly, Haywards Heath continues to struggle with low Membership. Dispute this, they are busy planning their annual Swimarathon event on Good Friday 2025, where Members from across the Zone will once again be asked to assist in the hopes that a Membership stall will attract new Friends and/or potential Lions. Most recently, Haywards Heath Lions were able to help local families over the Christmas period by providing much needed Sainsbury vouchers. The Club also undertook a bucket collection at Waitrose Supermarket on 14th December. As they will not be holding a Charter (due to their low numbers), Members, Friends and Family attended a Christmas meal at Lindfield Golf Club instead. (5 Members)

Horsham continue to run a wide variety of events covering service and fundraising. They recently ran MIAB events at Waitrose and Tesco. Notably, fundraising at the Roffey Club, where their Business Meeting is held, also raised £2,800 for the KSS Air Ambulance. Several Christmas (Santa) Collections were also held at Waitrose, Tesco and the Newbridge Garden Centre. Raising money for Horsham's Phoenix Stroke Club, they are also now busy planning for their annual Swimarathon, being held on 23rd March 2025 at the Pavilions In The Park. (19 Members).

Billingshurst Lions are a very healthy Club, with excellent links to their community. Their bookshop is now open an extra day (making it 5 days a week), due to the increased amount of volunteers (which in turn, helps provide a continual stream of potential new-members (not to mention income)). Since commencing almost forty years ago, it has now exceeded £800k in sales! Billingshurst Lions have once again been busy with ROAR and also local schoolbook-giveaways. Most recently, Members were busy on their annual Santa Tours & the Club also provided Christmas Hampers to local families in need. (34 Members).

Burgess Hill, as the largest Club in the Zone, continue to make great strides in serving their community. Their most recent PSA testing event resulted in 1,186 men being screened for prostate cancer. They routinely partner with local business and the Town Council in their annual Search for a Star Competition. At Christmas, in conjunction with Rotary, the Town Council and Market Place Shopping Centre, they ran a free Santa's Grotto, giving out sweets and gifts to children in need. The Club also provided £3,000 towards Christmas hampers, which they help pack and distribute. This year, to celebrate 70 years of service, Burgess Hill Lions were also recognised by the Town Council for the community support they provide, showing what an impact their Club and its Members have. (38 Members).

13.3 Zone Chairman 1C – Roger Bluff 2024 – 2025 Interim Report:

Bexhill have held lighting up event with mulled wine at Christmas. They also had Christmas hampers around town, along with a Santa's grotto. They have held Tesco collections over 3 days.

In the future they plan to help with a Dementia group assisting them with a music event.

Hailsham has the good news that they can continue to use the book shop premises for the next 18 months. This is an important fundraiser for them. They have held quizzes, tombola, Christmas events and recruitment stands for their club.

Hastings has ongoing processing of Community Services grants to local community good causes and individuals. They have supported the Salvation Army Christmas events providing goody bags for 52 individuals and helping with services at their Christmas lunch for the elderly.

NP&S have given £500 towards a Christmas lunch for "Sea friends" at St James Trust. They also held a Minibus excursion for Mencap to a Panto including £250 for ice creams, etc.

SEBI have held coffee mornings for LIBRA, both in person and virtually. They also attended a networking lunch at Hastings College to give a short talk on LIBRA. They raised just short of £100 which was made up to £100. With this and the coffee mornings the Club sent £300 to LIBRA.

SEBI are still collecting used Spectacles. Their members helped other Clubs and organisations over the Christmas period.

SEBI also has been raising funds for Brain Tumour Research with a 'Quiz Booklet' that they sold online, with a suggested donation of £3.

Uckfield have been busy spending 14 nights out with their Santa Sleigh with a hopeful profit of £6,000.00. They have donated to 4th Uckfield Rangers, a £1,000 donation to groups for a trip to Switzerland.

Uckfield have given to LCIF Spanish Floods Appeal the sum of £2,000. They also gave to LCIF Ukraine Wood Burning Stove Appeal of £1,000.

In the future Bexhill plans to help with a Dementia group assisting them with a music event.

Hailsham have booked a stall at 'What can you join in Halisham' event.

Hastings will be holding their Half Marathon on 23rd March 2025. They are also hoping to host a Prostate Cancer screening day sometime in 2025.

NP&S will have a visit to a Christmas Panto at Eastbourne on 5th January. They are also planning a Street collection at Morrisons for Marie Curie on 28th February.

SEBI will be holding a Zone Olympic event that will be 'The Crystal Maze' on 28th February 2025. SEBI has an Easter Eggs event planned with an Online Treasure Hunt.

Uckfield are planning DIABETES screening in early March. They have started the training for vision camera for schools.

At the beginning of our year before a Zone meeting was started, we held a presentation with Kent Sussex Surrey Air Ambulance presentation with Helene Pousine, Lion Howard Lee & District Governor Steve Carley thanked members of the Zone for all their significant contributions to the Bluebell Walk over the years. Certificates were presented to some members of the Zone who have played a big role in this hugely successful event which is planned to be repeated in May this year.
